Dear Woodland Springs Guest Swim Team Members:

We are excited about another great swim season. We are looking forward to a continuing relationship with swimmers from outside the neighborhood. This should serve as a reminder of some of the procedures:

- All swim families from last year will automatically be able to register again this year.
 - We are no longer accepting swimmers from outside the neighborhood due to the size of our team. Any family with a swim team history with WS swim team will be “grandfathered” members.
 - Non-Woodland Springs Swim Team members will participate in all SWIM TEAM activities. This will NOT include use of any Woodland Springs facilities outside the scope of Swim Team events. You will be asked to sign the agreement below demonstrating that you understand this policy.
 - The cost for swimming is \$75.00 per child, with a maximum amount of \$170.00 per family
